In addition to our efforts regarding restitution of immovable property in the former communist countries, the World Jewish Restitution Organization (WJRO) in cooperation with the Conference on Jewish Material Claims Against Germany (Claims Conference) works worldwide toward the restitution of Jewish-owned art, Judaica and other cultural property stolen or destroyed during the Holocaust. This includes such

cultural property held in the United States.

Advocates on behalf of Jews in Russia, Ukraine, the Baltic States & Eurasia הועד הלאומי למען יהודים ברוסיה, אוקראינה והמדינות הבלטיות ואירואסיה We have for many years encouraged U.S. museums to live up to the spirit of the Washington Conference Principles, the Terezin Declaration, and the Guidelines of the American Alliance of Museums (AAM). It has become clear, however, that when such art is located in the United States, federal legislation is needed to help ensure that the victims of Nazi-confiscated art theft will have their claims considered on the merits.

This past year we issued a *Report Concerning Current Approaches of United States Museums to Holocaust-Era Art Claims*, authored with the pro-bono assistance of the American law firm Dickstein Shapiro LLP. The report demonstrated that major U.S. museums have recently been

asserting defenses, such as statute of limitations, to avoid resolving on the merits claims by Holocaust victims and their heirs for the restitution of art looted by the Nazis. Use of these procedural defenses is an attempt to defeat claims for the restitution of art stolen by the Nazis by avoiding any adjudication of the substance of those claims. The report called for the enactment of legislation to extend statutes of limitation for Holocaust-era restitution claims.
